

CONSENT TO THE SCENARIO

This RELEASE is for a movie, the script, characters, all typecasting, storyline, dialogues of which have already been created by,

..... It includes the transfer of the rights specified within the scope of the Law No. 5846 on Intellectual and Artistic Works (FSEK) and other legal regulations to the producer of the Yed-i Velayet 7 provinces short film festival "Ehli Sanat Cinema and Culture Association".

TRANSFERRED RIGHTS:

- a) Reproduction right (within the scope of Article 22 of FSEK, the right to reproduce in Turkish and other languages, in the form of pellicle or similar material, CD, DVD, storage for digital transmission)
- b) The right of dissemination (within the scope of Article 23 of FSEK, the rights to be screened in Turkish language and within the scope of the festival in Turkey)
- c) Right of representation (within the festival, within the scope of Article 24 of FSEK)
- d) Cable / terrestrial / satellite, encrypted / unencrypted, free / paid TV, video, DVD, VCD, VHS, radio, cassette, cinema and all kinds of existing or emerging Sign, sound and / or image transmission means (Article 25 of FSEK)
- e) The right to process as a motion picture (Article 21 of FSEK)
- f) I hereby transfer the rights of publishing and transmission in computer and internet media and all kinds of wire and wireless audio and video transmission, storage and dissemination and/or publishing and transmission by means of any means and equipment for dissemination existing on the date of signing this "consent" or to be developed after the date of signing this "consent" to the YAPIMCI Ehli Sanat Sinema ve Kültür Derneği, that the license holder of the ESER in terms of the transferred rights and within the scope of the "consent" exclusively I accept, declare and undertake that it is Ehli Sanat Cinema and Culture Association.
- g) With this "consent letter", in the event that my "short film/documentary/documentary/ scenario of my work", which I have applied to the Yed-i Velayet 7 Vilayet Short Film Festival, which contains my personal information as well as the information below, is ranked or deemed worthy of any award as a result of the evaluation to be made by the festival jury.
- h) I accept, declare and undertake to take the necessary actions before the competent authorities in order to ensure the uninterrupted and full use of all the rights and authorizations I have transferred by the Festival Organization (Ehli Sanat Cinema and Culture Association) within the scope of the festival (Yed-i Velayet 7 Vilayet Short Film Festival) for the screenings to be held in the country or abroad within the scope of this "consent letter", and to issue or have the documents required to be issued to be used in any current or subsequent situation.
- i) I hereby accept, declare and undertake that I will not claim any rights or receivables for all these rights I have transferred and for the screenings to be held by the Producer, the Festival Organization throughout Turkey or abroad, whether paid or free of charge, or for public screenings.

i) I hereby declare and undertake that the Producer, Ehli Sanat Cinema and Culture Association may make agreements with one or more co-producers or individuals in order to create my scenario as a film, that it may work with the director, actors, voice actors, musicians and technical infrastructure service providers, that I will not object to them, that I will not claim any rights for this or any other reason and that I will not have any other receivables.

j)The festival organization may distribute the copies of the film/documentary/work for which I wrote the script to the relevant authorities and persons (Ministry of Culture, General Directorate of Cinema, Governorships, District Governorships, Municipalities, Associations, Chambers, Persons representing these institutions, etc.). It can design and give it as a prize or gift. I accept, declare and undertake that I have transferred the rights of participation and representation of my script, which has been turned into a film, to the Ehli Sanat Cinema and Culture Association, and that I will not claim any rights or receivables related to them.

k)However, if my script is ranked as a result of the review and evaluation to be made by the festival jury, the award fee determined by the festival organization must be paid to me. These prices will be the same as the prices determined on the festival's official website www.7shortfilms.com and in the file submitted to the General Directorate of Cinema. The determined amounts will be paid to me by making the necessary legal deductions (tax, fee, etc.). I accept, declare and undertake in advance that I will not object to this situation.

l) The transfer of the rights to my script/work is for a period of 99 years (Ninety Nine Years) starting from the date of signature of the "consent".
