

SCRIPT DEED OF CONSENT

This DEED OF CONSENT is intended to transfer by of the rights under the Law No. 5846 on Intellectual and Artistic Works (the "LIAW") and other respective legislation in respect of the original cinematographic WORK named.....to be shot as documentary, short film or film, for which the script, characters, typesetting, story and dialogues have already been created, to "MY Elit Yapım-Seda Sürmeli", the producer of the short film festival "Yed-i Velayet 7 Vilayet".

RIGHTS HEREBY TRANSFERRED:

- a) Reproduction Rights (reproduction rights under article 22 of the LIAW in Turkish and other languages as storage for digital transmission on unexposed film or similar materials, CD, DVD)
- b) Distribution Rights (screening rights under article 23 of the LIAW in Turkish language and within the festival in Turkey)
- c) Representation Rights (under article 24 of the LIAW within the festival)
- d) Right to Transmit to Public through cable/ terrestrial/satellite, encoded/unencoded, free/ paid TV, video, DVD, VCD, BFS, radio, cassette, cinema and all other current or future medium for transmission of signs, sound and/ or pictures (article 25 of the LIAW)
- e) Right to process as motion picture (article 21 of the LIAW),
- f) Right to broadcast and transmit through computer environment and Internet as well as all other tools for the transportation, storage and broadcast of sound and picture and/ or any other tools to that end whether existing at the time of the signing hereof or to be developed after the signing hereof; I hereby agree, declare and undertake that I have transferred the above mentioned rights to the producer My Elit Yapım-Seda Sürmeli and, that the producer My Elit Yapım-Seda Sürmeli is the exclusive license holder of the WORK in respect of the rights hereby deferred and under the scope of this deed of consent.
- g) I hereby agree, declare and undertake that in case my script of my "short film/ documentary/ work" as described below, for which I have applied to the Short Film Festival "Yed-i Velayet 7 Vilayet", is placed or awarded as a result of an assessment by the festival jury;
- h) I shall perform all procedures and transactions before respective competent authorities and I shall issue or cause to be issued all documents as may be required for use in an existing or subsequent event so that all rights and powers I have hereby transferred are exercised by the Festival Organization (MY Elit Yapım-Seda Sürmeli) in an uninterrupted and complete manner for the screenings of the script of my film/ documentary/ work within the festival (Yed-i Velayet 7 Vilayet Short Film Festival) in Turkey and abroad.
- i) I hereby agree, declare and undertake that I shall not claim any right for my rights I have hereby transferred and for the screenings by the Producer, the Festival Organization in Turkey or abroad either for fee or free of charge or as public screenings.
- j) I hereby agree, declare and undertake that the Producer MY Elit Yapım- Seda Sürmeli may enter into agreements with one or more co-producers or individuals, and work with any directors, performers, voice actors, musicians and individuals and companies offering technical infrastructure services for the purpose of creating a film based on my script, that I shall not claim any right and I have no further receivables in connection therewith.
- k) The Festival Organization may distribute the copies of the film/ documentary/ work, the script of which has been written by me, to the respective authorities and individuals (Ministry of Cultural Affairs, General Directorate of Cinemas, Governorates, District Governorates, Municipalities, Associations, Chambers as well as those representing such authorities). The Festival Organization may design and distribute the same in the form of an award or gift. I

hereby agree, declare and undertake that I have transferred to My Elit Yapım Seda Sürmeli the right for the participation and representation of my scenario, which a film is based on, in such festivals organized in Turkey and abroad and, that I shall not claim any right in connection therewith.

l) However, in case my script is placed as a result of an assessment by the festival jury, I must be paid the amount of 2,000 Turkish Liras, which is the award determined by the festival organization. Such amount shall be the same as that indicated in the festival's official web site "www.7kisafilm.com and in the file submitted to the General Directorates of Cinemas. Such amount shall be paid to me after the deduction of the respective legal amounts (taxes, charges etc.). I hereby agree, declare and undertake that I shall not object thereto.

m) The transfer of the rights of my script/ work shall be for a period of 99 (ninety-nine) years from the signing of this deed of consent. This deed of consent is composed of two pages and signed by the parties on/...../.....
